<p>Tuition covers salaries & benefits for the staff at Incarnation School.</p> <p>The actual cost to educate each child at Incarnation for the 2009-2010 school year will be in excess of \$5,600. (The difference between the tuition and the actual cost will be made up through the fundraisers listed here.)</p> <p>All monthly tuition is to be paid through FACTS Tuition Management Co. (you may elect to make payments on a ten (10) or eleven (11) month basis.)</p> <p>The full tuition amount may be paid directly to the school. (A three percent (3%) discount for full payment of tuition will be given if paid on or before August 1, 2009. After this date, no discount will be applied.)</p>	<p>New Applicants Registration Fee: \$50.00 per student (non-refundable) Upon acceptance: \$200.00 (non-refundable) secures a place in the class. (This \$200.00 is the book fee for one child.) Book fee for additional siblings is \$200.00 per child and are due by August 15, 2009. Entrance Testing Fee: \$50.00 per child (non-refundable)</p> <p>Re-registration for Current Families Re-Registration Fees: \$250.00 (non-refundable) secures a place in the class. (\$50 re-registration & \$200 book fee for 1 child.)</p>	<p>Jog-A-Thon (tax deductible donation): \$150.00 for 1 child \$300.00 for 2 children \$450.00 for 3 or more children</p> <p>OR Families wishing to defray the mandatory donation may do so by soliciting one (1) business sponsorship @ \$250.00 per child.</p> <p>Annual Auction Dinner: Mandatory donation: \$150.00 due by February 1, 2010 (pays admission for 2 people)</p> <p>Auction Raffle tickets: \$150.00 Each family is responsible for selling or paying for \$150 in raffle tickets.</p>	<p>Mandatory donation: \$200.00 per family to support the SCRIP program due by November 15, 2009.</p> <p>Optional: A family may choose to participate in the SCRIP program by registering with e-Scrip and/or by placing SCRIP orders through the Home Messenger or buying SCRIP on Sundays.</p> <p>Profit earned: Any profit from SCRIP will be split 50/50 between the school and the family. (e.g. if profits earned sum \$200, the school will keep \$100 and the family can request a refund for the \$100 dollars profit share). Refunds must be requested by the end of May 2009. The family may also choose to donate its portion of the profit to the fund of its choice (e.g., Electrical/Air Conditioning, Athletic Program, Music, Yearbook, etc.).</p>	<p>40 hours total per year per family.</p> <p>Optional payment: A family may opt to pay \$500.00 for the year in lieu of performing their service hours; due by November 15, 2009.</p> <p>Uncompleted Hours: \$25.00 per hour will be charged for each hour not completed by May 31, 2010.</p>

***Criteria for Participating Parishioners**

In order to qualify as a participating parishioner, a family must actively worship at Incarnation Parish and be involved in the liturgical life of this parish. At the very least, this means attending Mass every Sunday. This participation must be reflected by registration in the parish from January 1, 2008 to December 31, 2008 and during that calendar year having made a minimum contribution of \$500.00 to the Church.
