<p>Tuition covers salaries & benefits for the staff at Incarnation School.</p> <p>All monthly tuition is to be paid through FACTS Tuition Management Co. (you may elect to make payments on a ten (10) or eleven (11) month basis.).</p> <p>The full tuition amount may be paid directly to the school. (A three percent (3%) discount for full payment of tuition will be given if paid on or before August 1, 2011. After this date, no discount will be applied.)</p>	<p><u>New Applicants:</u></p> <p>Registration Fee: \$50.00 per student (non-refundable) Entrance Testing Fee: \$50.00 per child (non-refundable) Upon acceptance: \$200.00 (non-refundable) secures a place in the class. (This \$200.00 is the book fee for one child.) Book fee for additional siblings is \$200.00 per child and are due by August 15, 2011.</p> <p><u>Re-registration for Current Families:</u></p> <p>Re-Registration Fees: \$250.00 (non-refundable) secures a place in the class. (\$50 re-registration & \$200 book fee for 1 child.)</p>	<p><u>Jog-A-Thon (tax deductible donation):</u> \$150.00 for 1 child \$300.00 for 2 children \$450.00 for 3 or more children</p> <p><u>OR</u> Families wishing to defray the mandatory donation may do so by soliciting one (1) business sponsorship @ \$250.00 per child.</p> <p><u>Annual Auction Dinner:</u> Mandatory donation: \$150.00 due by February 1, 2012 (pays admission for 2 people)</p> <p><u>Auction Raffle tickets:</u> Each family is responsible for selling or paying for \$100 in raffle tickets.</p>	<p><u>Mandatory donation:</u> \$250.00 per family to support the SCRIP program due by October 15, 2011.</p> <p><u>Optional:</u> A family may choose to participate in the SCRIP program by registering with e-Scrip and/or by placing SCRIP orders through the Home Messenger or buying SCRIP on Sundays.</p> <p><u>Profit earned:</u> Once \$250.00 in profit is attained through scrip purchases, the mandatory donation of \$250 (Paid by Oct. 15) will be refunded. Refunds must be requested by the end of May 2012. Any profit over \$250 will be split 50/50 between the school and the family. The family may also choose to donate its portion of the profit to the fund of its choice (e.g., Electrical/Air Conditioning, Athletic Program, Music, Yearbook, etc.).</p>	<p>40 hours total per year per family.</p> <p><u>Optional payment:</u> A family may opt to pay \$500.00 for the year in lieu of performing their family participation hours; due by November 15, 2011.</p> <p><u>Uncompleted Hours:</u> \$25.00 per hour will be charged for each hour not completed by May 31, 2012.</p> <div style="text-align: center;">  </div>

***Criteria for Participating Parishioners**

In order to qualify as a participating parishioner, a family must actively worship at Incarnation Parish and be involved in the liturgical life of this parish. At the very least, this means attending Mass every Sunday. This participation must be reflected by registration in the parish from January 1, 2010 to December 31, 2010 and during that calendar year having made a minimum contribution of \$500.00 to the Church.

A copy of the year-end contribution statement from the Church must be attached to your application in order to verify your contribution.
